





- Q. Which of the following groups of people do you think we should focus on?








Q. How do you think your *household's* financial situation has changed in the last year?



Q. Over the last year, have you had to make cuts to any of the following, due to your personal financial situation?





Which of the following have you done?




Of the 50% of <u>all</u> respondents who said they have reduced heating use:


Which of the following ways have you done this?




Of the 55% of <u>all</u> respondents who have made cuts to food over the last year: Which of the following have you done?




Of the 55% of all respondents who have made cuts to travel / vehicle costs over the last year: Which of the following have you done?










Q. Thinking ahead to this time next year, how do you think your financial situation will change compared to now?






Q. Over the next year, how likely is it that you will have to make cuts / further cuts to the amount you spend / use?







- 90% of respondents who were previously automatically receiving Winter Fuel Allowance due to their age no longer do so because they do not meet the new benefit requirement.
- Similarly, 95% of respondents who would have received Winter Fuel Allowance for the first time this winter based on age alone, did not meet the new benefit requirement.
